This waiver and release is intended to and does release Northern Lehigh Swimming Pool Association, Inc. from any and all liability for damages or injuries on account of or in any way related to or growing out of my negligence, the negligence of third parties and Northern Lehigh Swimming Pool Association, Inc.'s negligence. This is not intended to release Northern Lehigh Swimming Pool Association, Inc. from any liability resulting from their intentional conduct.

I further covenant and agree not to institute any claims or legal action against Northern Lehigh Swimming Pool Association, Inc. for any claim released by this Agreement. I further agree that should any claim be made against Northern Lehigh Swimming Pool Association, Inc. in contravention of this Agreement, including but not limited to derivative claims, I will protect, defend and completely indemnify (reimburse) Northern Lehigh Swimming Pool Association, Inc. for any such claim and expenses including attorney's fees and costs incurred by Northern Lehigh Swimming Pool Association, Inc. in defending themselves or security indemnity hereunder.

2. I understand that Northern Lehigh Swimming Pool Association, Inc. is not responsible for any lost, stolen, or damaged valuables or property.
